COVID-19 has impacted us in a very big way. There is an acute shortage of workers in Bhiwandi and the yarn market is not functioning regularly as there are restrictions on the movement of customers from Bhiwandi to the yarn market in Mumbai. We expect normalcy to be restored once all these restrictions on the movement of people are gradually eased and the pace of vaccinations picks up.
